**Full-Day Kindergarten Tuition Information:**

Listed are the annual gross income guidelines to help your family determine financial eligibility. (Financial aid is available to Bellevue residents only.) If you think you may qualify for financial aid, you must submit a completed Financial Aid Application for approval, including proof of current income. Your application will be reviewed by the Business Office for eligibility. Income eligibility is based on gross income.

\_\_\_\_\_ **FULL FEE** – I agree to pay \$3,200 for the year. I understand this tuition will be charged at \$320 per month.

\_\_\_\_\_ **PARTIAL FEE** – If eligible, I agree to pay \$1,500 for the year. I understand this tuition will be charged at \$150 per month.

\_\_\_\_\_ **NO FEE** – If eligible, I understand there will be no charge for tuition.

*Tuition is charged from September through June, regardless of the number of actual days of service in any month. In the case of 'multiples,' each child after the first, in any tuition category, enrolled in FDK the same year, will receive a 10% discount. Tuition credit is not granted for temporary absences.*

**Enrollment**

- Enrollment date of the 1<sup>st</sup> to the 15<sup>th</sup> of the month = full monthly tuition obligation
- Enrollment date of the 16<sup>th</sup> to the end of the month = half monthly tuition obligation

**Withdrawal**

- Withdrawal during the 1<sup>st</sup> to the 15<sup>th</sup> of the month = half monthly tuition obligation
- Withdrawal during the 16<sup>th</sup> to the end of the month = full monthly tuition obligation

Tuition payments are due on or before the 20<sup>th</sup> of each month prior to the month of service. If your child enrolls after the start of the school year, the first tuition payment is due in the Business Office on or before the first day of Full-Day Kindergarten for your child. Payment by an NSF check is considered the same as nonpayment. A \$10.00 fee may be assessed for any NSF or returned check. Accounts that are two months past due will be referred to a collection agency, and your child will be moved to the half-day kindergarten program.

I hereby acknowledge that I understand and agree to comply with the policies listed above. In addition, should I qualify for financial aid, I agree to inform the District of any decrease in household size or increase in household income that could affect my eligibility for financial aid. I further understand that I am responsible for all tuition incurred should financial aid not be granted.
